Item 1: SCEA leadership sent an MOU to Human Resources asking that the The Facilities Vision Plan responses be anonymous and not use the information in an evaluative manner. However, HR refused to sign the MOU in case a respondent entered a violent or threatening response into the survey. **Item 2:** Two new members have enrolled in SCEA and this brings the total new member number up to 38. This is 12 away from the goal of 50 new members for the 24-25 Academic year. **Item 3:** An information request and demand to bargain was submitted to the District centered on the Middle College. **Item 4:** The next Governing Board meeting will be held at HEC Otay Mesa on 3/17. The SCEA will host a viewing party at the Chula Vista Campus with food and games to encourage participation at the Governing Board. **Item 5:** SCEA will host a game night on Sunday April 13. More information will be forthcoming.

5Prop 55 ExpirationReynoldsInformation20 minOverview: Since 2012, Props 30/55 have generated an average of \$9 billion annually for California public schools

and community colleges. \$7.7 billion to TK-12 school districts annually, and nearly \$1 billion to community colleges. If Prop 55 is not extended, it could lead to a loss of this critical funding, which could result in substantial educator layoffs thus impacting students. Prop 55 was approved by voters in 2016, extending Prop. 30's personal income tax increases on California's highest earners until 2030. The tax extension applies to California's wealthiest residents-those filing jointly with more than \$700,000 in personal income. In order to win, the SCEA can 1.) educate members on the need for an extension of Prop 55, 2.) gather signatures at SWC at the start of the 25-26 academic year to qualify the initiative, and 3.) integrate Prop. 55 extension with the local Board of trustees campaigns and get

out the vote. Currently, the SCEA has drafted a resolution to support the extension of Proposition 55 and is committed to organizing to win this critical extension and prevent any cuts to education funding in California. SCEA will work together in its chapter to gather signatures at school sites and in the local community to ensure this funding continues. Comments from Reps: A rep made a motion to support the resolution to extend Prop 55. One rep suggested it would be more appropriate to wait to support the extension until the name of the Proposition has been clarified (The Secretary of State will give this a new number once it gets on the ballot), and something more formal is submitted from the CTA. Another rep suggested the motion on the floor could be to create the draft of the resolution coming back to SCEA for a vote, and noted there is no reason to resist supporting the extension of Prop 55, even if the name has not been solidified. The CTA Rep clarified that when the signature gathering occurs in the Fall of 2025, there will be concrete information. A request was made and accepted to postpone the motion in support of the resolution until the next Rep Council meeting so Reps have a chance to share with their constituents.

Item 1: Over the last few weeks the SCEA Bargaining Team has passed to the District: Article XVI: Distance Instruction, Article IV: Workload, Article V: Leaves, and the Tenure Review Manual, and is awaiting their counters. The only article the SCEA Bargaining team still needs to get to the District is Article VIII: Health and Welfare, but it should be passed to them next week. Item 2: The Bargaining Team has been working on MOUs concerning BOTS and Evaluations, and the Facilities Survey. The District has put in writing that they do not intend to use the survey results in an evaluatory manner; however the District was not willing to formalize that intent in an MOU. Item 3: The Bargaining Team is keeping a focus on the Middle College and its potential impacts on workload. Item 4: The District turned down proposed language on Remote Work in Article IV: Workload because it was suggested it was in the wrong place. So the language was moved intact to Article XVI which was formally called District Instruction, and the new title would now be Distance Instruction and Remote Work.

A motion was made to approve Reverse Dues for the Political Action Committee (PAC). The Political Action Committee (PAC) is charged with getting labor-friendly Governing Board members elected. In 2026, three Governing Board seats will open up. Currently those seats are held by Don Dumas, Robert Moreno, and Corina Soto. In the past, Rep Council was asked to transfer lump sums of money into the PAC during election cycles. Moving forward, the SCEA is interested in taking a portion of the already collected dues, and allocating it to the PAC fund. Using a Reverse Dues process, \$2 dollars per Part-time member, and \$4 dollars for each Full-time member will be contributed unless a member decides to opt out. The goal is to have this implemented by Fall 2025. The motion passed by consensus.
